## RENTAL PURCHASE OPTION TERMS AND CONDITIONS

**ADDENDUM TO RENTAL AGREEMENT.** Upon full completion of the Option Details and proper execution, this Rental Purchase Addendum is incorporated into the Rental Agreement and governed by the terms and conditions thereof. The term Rental Agreement as used herein shall mean the Rental Agreement for the Equipment and the Rental Terms and Conditions incorporated therein.

**EXERCISE OF OPTION.** This Rental Purchase Addendum provides the Lessee with the option to purchase the Equipment (the "Option") on the terms and conditions contained in this Rental Purchase Addendum. After the expiration of the Minimum Rental Period specified herein but on or before the date of the Option Expiration, Lessee must provide written notice to Cross Country Infrastructure Services USA, Inc. ("CCI") of its intent to exercise its option to purchase any or all of the Equipment under this Rental Purchase Addendum ("RPO Notice") provided that at the time of the RPO Notice: i) the Rental Agreement is in effect as to the Equipment contained in the RPO Notice, ii) Lessee is not in default of the performance of any of Lessee's obligations under the Rental Agreement, and iii) Lessee has fully paid all balances owed to CCI under any equipment rental agreements Lessee has with CCI.

**RPO PRICE.** Within five (5) business days from the receipt of a valid RPO Notice, CCI shall provide to Lessee a statement of the RPO Price which shall be the sum of the "Gross Purchase Price", plus all sums invoiced but not yet due for the Equipment, less the amount of rentals paid multiplied by "% Rental Payment Applied". CCI's statement of the RPO Price shall be conclusive on the amount of the RPO Price.

**RPO PAYMENT.** Lessee must make payment to CCI in good US funds in the amount of the RPO Price within five (5) business days after the date of the statement of the RPO Price or Lessee's RPO Notice expires and the Rental Agreement remains in effect.

**TRANSFER OF EQUIPMENT.** Within five (5) business days of Lessee's payment to CCI of the RPO Price, CCI shall deliver to Lessee the necessary bills of sale or endorsed certificates of title necessary to transfer the Equipment to Lessee, free and clear of all liens and encumbrances not specifically placed on the property by Lessee.

**NOT ASSIGNABLE.** This Rental Purchase Addendum is not assignable by Lessee.
