3. Town of Gramercy tax of 1.5% (For all sales within the incorporated town of Gramercy)
4. Town of Lutcher tax of 2% (For all sales within the incorporate town of Lutcher)

This certificate cannot be used to exempt the State of Louisiana sales tax. Furthermore, the exemption granted to this location cannot be used to make purchases from any other location of this business entity.

PLEASE MAKE COPIES OF THE ORIGINAL CERTIFICATE AND ISSUE TO YOUR VENDORS AS NECESSARY. WRITE THE NAME OF THE VENDOR ON THE CERTIFICATE COPY AND SIGN YOUR NAME TO IT UPON ISSUANCE.

The sales tax must be collected on the retail sale of these purchases and remitted directly to the St. James Parish School Board Sales & Use Tax Department. Failure to do so will subject the taxpayer claiming the exemption to revocation of the certificate and to the civil and criminal penalties provided for in the St. James Parish School Board and St. James Parish Council Sales and Use Tax Ordinances.

This exemption certificate is issued based on your current qualifications. This Department reserves the right to periodically review your records to determine if the minimum qualifications are being maintained. If at any time in the future the required qualifications are not met, the exemption certificate may be revoked.
